### Cost and charges impact on the investment return

The example demonstrates the total costs and charges impact on the return of the investment made by the client. The investment return shown in the example is used for illustrative purposes and it does not guarantee the stated return in future. The example assumes that EUR 10 000 is invested in the fund for a term up to 3 years, the return of the fund is 5% per annum (net of ongoing costs and transaction costs) and the costs and charges are calculated based on the assumptions mentioned in the first section of this document.

Based on assumptions of the example

- costs charged in the first year reduce the investment result by EUR 326,29 and the return of the investment from 7,21% to 3,95%;
- costs charged for two years reduce the investment result by EUR 579,86 and the annual return of the investment from 7,21% to 4,47%;
- costs charged for three years reduce the investment result by EUR 863,21 and the annual return of the investment from 7,21% to 4,65%;
